"EUPAD" IN STERILIZATION OF THE SURGEON'S HAND.

To the Editor of "THE INDIAN MEDICAL GAZETTE."

SIR, - Bacteriological tests show that it is very difficult to sterilize completely the hands of the surgeon, and it is well known that only a very few number of antiseptic agents answer the purpose, but almost all of them are inconvenient and unpleasant to the hands to use. Further, it is difficult to obtain the antiseptic agents everywhere. On the other to obtain the antisentic agents everywhere. On the other hand, we know that the surgeon's hands are the most likely hand, we know that the surgeon's hands are the most likely sterilized. I believe "Eupad" (a compound powder made with ordinary commercial bleaching powder or chlorinated lime and boracic acid in an equal part) can be used to sterilize the surgeon's hands. It has proved itself experimentally and in actual practice that Eupad is one of the strongest known antiseptics. It causes no roughness, irritation, or benumbment of the skin; it is non-poisonous and cheap. Enpad can easily be used for the hands thus:—After washing the hands with soap and water put a tablespoonful or more on the hand with enough water to make a paste and rub it well to the hands until it forms a smooth cream like paste; then wash in sterilized water. It gives a pleasant cool feeling, and is, I believe, completely satisfactory as a method of sterilization.

I shall be much obliged if any bacteriologist will kindly undertake experiments to prove this method and let us know the result through this paper.

Also, I have successfully used Eusol (25 per cent. solution of Eupad) internally by mouth and rectum in the treatment of typhoid fever, ptomain poisoning, enteritis, dysentery, etc., but it has been used in so limited a number of cases that its value cannot be determined. I hope some light may be thrown on this method of treatment of germ diseases in the future.

Captain John Maikand Stenhouse, R.A.M.C., who was reported as wounded towards the end of July, died of his wounds on 25th August. He was the son of the late Major-General W. Stenhouse, of the Indian Army, and was educated at Cambridge, where he graduated as B.A. in 1900, and as M.B. and B.C. in 1903, and at the London hospital, where he held the appointments successively of house surgeon, house

physician, receiving room officer, resident anæsthetist, senior clinical assistant for outpatients, and clinical assistant in the outpatient ayral department. He was then medical attendant to Prince Leopold of Battenburg, with whom he spent the winter at Khartum, after which he joined the staff of the Union Medical College, Pekin. He served with the Chinese Imperial Force in the Boxer-rising, and received a decoration from the Emperor. He took a temporary commission as Lieutenant in the R. A. M. C. on 24th August, 1914, and was promoted to Captain on completion of a year's

Captain Thomas Cameron Houston, R.A.M.C. (T.F), died on 25th August, 1916, of wounds, received the same day. He was a nephew of Mr. James Houston, of Linkieburn, Muirkirk, Ayrshire, and was educated at Glusgow University, where he graduated as M.B. and Ch.B. in 1915. Immediately afterwards he joined the Lealand Mounted Brigade Field Ambulance as a Lieutenant on 2nd April, 1915, and was promoted to Captain on completion of a year's service.

Major Norman Ernest Jasper Harding, R.A.M.C., died of cholera at the Colaba Military Hospital, Bombay, on 10th August, 1915, aged 41. He was born on 2nd February, 1875, and educated at University College, Liverpool, and in the University and Extramural Medical School at Edinburgh, where he graduated as M.B. and Ch.B. in 1900, also taking the diploma in tropical medicine in the same year. After wallfairing he saved as a civil surgeon in the Sauth Africa the Assertation of the Sauth Africa to the Sauth qualifying he served as a civil surgeon in the South African war; after which he entered the RAM.C., as a Lieutenant,

war; after which he entered the R.A.M.C., as a Lieutenant, on 1st September, 1902, becoming Captain on 1st March, 1906, and Major on 1st June, 1914. He was severely wounded in the South African war, in which he gained the Queen's medal with two clasps, and the King's medal.

Lieutenant-Colonel George Michael James Giles, Bengal Medical Service, retired, died at Plymouth on 24th August, 1916, aged 62. In his early service he spent some years as Surgeon Naturalist In his early service he spent some years as Surgeon Natu alist on the Royal Indian Marine Steamer Investigator, and in 1886-87 accompanied the late General Sir William Lockhart on an exploring expedition on the Pamirs. Subsequently he went into civil employment in the Central Provinces and in the North-West (now the United) Provinces. After his retirement he lived for some time at Plymouth, and later on retirement he lived for some time at Plymouth, and later on settled at Portsmouth, County Frontenac, Ontario, Canada. At the beginning of the war he joined the Canadian Army Medical Corps, with which he came to England, and was for some time in charge of Bencote House hospital, Oxford. He was the author of several scientific works, Kala-azar and Beri-beri, Handbook of the Gnats or Mosquitos, Climate and Health in Hot Countries, Outlines of Tropical Climatology, &c.
